#### GORBACHEV'S DILEMMAS DISARMAMENT AND NICARAGUA

Pity poor Gorbachev. He has such heavy responsibilities. As chief executive officer of the Multinational Communist Corporation, which is devoted to the establishment of the communist domination of the world, he is confronted with the necessity to find solutions to many dilemmas.

One of these dilemmas is familiar to most of us from our own experience, though we experience it on a much smaller scale. How can he select the best programs in which to invest limited funds? He simply does not have enough money to meet all demands and requests. Which shall he choose to support?

Consider the following example. The leaders of the military forces want him to retain all missiles and build more. The leaders of the Sandinista rulers of Nicaragua want more weapons to arm their massive army so that they can maintain the communist dictatorship in Nicaragua and support communist revolutionary forces in neighboring countries. Which project deserves priority? Should he build more missiles or should he supply the rulers of Nicaragua with more attack helicopters, tanks, artillery and "advisers"?

# **Basic Strategy**

A wise decision demands an accurate assessment of the role each is playing in the overall strategy for world conquest. This strategy is expressed by the formula for the conquest of the U.S.A.?? 'External encirclement, plus internal demoralization, plus thermonuclear blackmail, lead to progressive surrender."

#### Encirclement

The primary purpose of the nuclear missiles is to paralyze the U. S. will and thus assure that no effective action is taken to prevent the incremental additions to the hostile forces that are encircling the U. S . A.

These additions are primarily due to successful "National Liberation Revolutions". Once a revolution wins initial success, its power must be consolidated. If the regime, which is established after a successful revolution is non? communist, it must be supported for a time and encouraged to adopt an "anti?imperialist", meaning an anti?U.S.A., policy. In due course, a regime, which is merely anti?imperialist, must be subverted and replaced by a communist dictatorship.

Once a communist dictatorship is established, the Soviet Union accepts the responsibility of maintaining it in power. The acknowledgment of this responsibility is formalized in the Brezhnev Doctrine. The acceptance of it is proven by the Soviet troops in Afghanistan and Poland, the Soviet helicopters in Nicaragua, and the massive subsidies of Cuba.

#### **Nuclear Mission**

The ability of the Soviet Union to deter 11. S. action to prevent increasing encirclement will not be diminished by the removal of some or all Intermediate Range Missiles from Europe and Asia. Enough missiles to create justifiable fear of a nuclear war between the Soviet Union and the U. S. A. will remain. Any action that could cause such a war will appear irrational and suicidal.

Therefore, it is permissible for Gorbachev to negotiate treaties that will dramatically diminish the number of nuclear missiles in existence as long as enough remain to make nuclear war "unthinkable".

Long?Established Communist Strategy

Actions by Gorbachev, which will reduce expenditure on missiles and leave more money available for the subsidies of Cuba and Nicaragua, is in harmony with long?established communist policy.

In 1957, 1 gave evidence on the "communist mind" to the Committee on Un? American Activities of the U. S. House of Representatives. I concluded my testimony with this statement:

"The basic communist strategy in 1952 renounced the inevitability of World War III. World conquest without war, which is called co?existence, became their basic strategy. I would not be surprised if they would like some disarmament, as all they look to from military might is a stalemate. If they can reduce the armament burden and retain this stalemate, they will have more funds available for propaganda, and political and economic warfare."

By his willingness to enter into Disarmament Treaties with the U. S. A., Gorbachev is following long?established policy guidelines. He will not be willing to cease his military and economic support of the Sandinista rulers of Nicaragua, since that would entail a major renunciation of communist strategic interests.

The Deadly Trap

The U. S. A. is facing a deadly trap in Nicaragua.

The Presidents of the Central American nations??El Salvador, Costa Rica, Honduras, Guatemala and Nicaragua?? have designed a so?called peace program for the area. As Fred Barnes writes in the August 31 edition of the liberal magazine, THE NEW REPUBLIC:

"It has no mechanism for forcing the Sandinistas to democratize, doesn't halt Soviet and Cuban aid to Nicaragua, and may strand the contras without military assistance while the Sandinistas rearm." (Page 10)

The fact that the Sandinista leaders claim to support this plan is significant. They have no intention of surrendering power. They are devotees of the doctrine that "the greatest crime that a communist can commit is to have state power and then lose it."

It is easy for the Sandinistas to pay lip service to democracy knowing that it is impossible to hold a free election in Nicaragua in the present situation. A genuine free election would require that the Sandinistas surrender their monopoly of power in advance. Their control of the military, the police, the Committees for the Defense of the Revolution, and the News Media gives them awesome powers.

Consider the plight of a typical Nicaraguan voter. He or she is a campesino with a sizeable family. Providing food for the children is the dominant responsibility. The food is secured through ration cards which are distributed monthly. The dispenser of the card, is the leader of the block "Committee for the Defense of the Revolution" which supervises all the activities and attitudes of the residents in a designated number of dwellings, and which reports to a higher authority.

Displeasing the block captain can bring terrible retribution upon the whole family. Imagine the consequences of withholding the ration cards for even a few days. Children get hungry and unhappy. It is wiser to keep in the good graces of the lord and master who controls the food. If he says "vote", you vote. It is also probable that the vote will be for the one favored by the food master. Even if the ballot is allegedly secret, who can be sure?

In these circumstances, the Sandinistas have little to fear from a "free" election.

Add to the power of the Committees a practical monopoly of the press, radio and T. V., the control of transportation, the intimidating potential of the police and army, and the threatened or actual violence of the "Turbos", the "divine mobs" who attack opposition political rallies. It is obvious how heavily the scales are weighted in favor of the Sandinistas.

Even if the Nicaraguan Government allows the closed newspaper, LA PRENSA, to open and the silent Catholic Radio Station to broadcast, the bias remains overwhelmingly in favor of the Sandinistas.

#### The Contras

If the freedom fighters are immobilized, even temporarily, it will be exceedingly difficult for them to regain their present momentum. If they are disbanded, it will be practically impossible for them to be reestablished.

The historic communist strategy is?? Talk and Fight. Both are weapons used in conquest. The talk weakens, confuses and isolates the enemy and makes him vulnerable to the final assault. The Sandinistas may appear reasonable and willing to compromise until the freedom fighters are disbanded when they will have little difficulty finding a plausible justification for tightening the screws on Nicaraguans and resuming support for guerrillas attacking the government forces in neighboring countries.

The wonder is that the Contras have achieved so much, considering the massive support the Sandinistas have received from Soviet and associated sources. This support dwarfs anything that the freedom fighters have received from the C. I. A. or friendly forces.

The freedom fighters represent the Nicaraguan people. The recruits, who sustain and constantly enlarge the Contra ranks, prove that they are a force of great potential power.

It is a foolish dog who throws away the bone in his mouth for the reflection in the water below, however enlarged and enticing it may appear.

Gorbachev will welcome the money he will save from an agreement to reduce nuclear weapons in order to invest it in the consolidation of communist power in Nicaragua and the consequent conquest of all Central America. A major step towards the eventual surrender of the U. S . A. will have been taken.

#### COMMUNIST CAMPAIGN AGAINST JUDGE BORK

One of the present priorities of the U. S. Communist Party is to prevent the confirmation by the U. S. Senate, of Judge Robert Bork to the Supreme Court.

The communist press is publishing numerous articles which attack Judge Bork, and is advertising methods by which his nomination can be defeated. For example, the August 7 edition of the communist newspaper, the PEOPLE'S DAILY WORLD, contains the following articles and cartoons:

Coalition sets anti?Bork rallies for Aug. 12

WASHINGTON? A coalition of organizations of the nation's Black elected and appointed officials Thursday launched a drive to mobilize millions of people this summer to defeat President Reagan's nomination of Robert Bock to the Supreme Court.

It will include noontime demonstrations already scheduled for at least II U.S. cities on Aug. 12, Civil Rights Day.

Rep. Mervyn Dymally (D?Calif), chair of the 23?member Congressional Black Caucus, said the new anti?Bork coalition will merge activities with more than 100 civil rights, labor and other organizations representing tens of millions in a campaign to "mobilize grassroots opposition" during the summer congressional recess. "We have an absolute responsibility to take this issue to the people of this nation," Dymally told a press conference.

The Senate Judiciary Committee ? is scheduled to begin hearings on Boric's nomination in mid? August, with a vote as early as Oct. 1.

Rep. John Conyers (D?Mich), chair of the Judiciary Subcommittee on Criminal Justice, said Bork's role in firing Watergate Special Prosecutor Archibald Cox in 1973 "should itself disqualify him from sitting on our highest cowl." Conyers helped prepare articles of impeachment against President Richard Nixon in 1974.

#### **NAACP** Legislative Director

Althea T.L. Simmons said lobbying packets have been sent to 2,100 NAACP chapters and 100 mass organizations to spur the grassroots fight against the Bork nomination. She called for a letter writing campaign, and visits with senators during the next 50 days to press for Boric's rejection.

Rep. Waiter Fauntroy (D?DC), president of the National Black Leadership Roundtable, said Bork would upset the balance of the court. "At issue is whether we will permit the civil rights, civil liberties and social gains made over the last half century lobe rolled back," Fauntroy said. He said Bork should be rejected on the basis of his opposition to voting rights and his lack of concern for First Amend

Amendment guarantees of free speech.

Former Mayor Richard Hatcher of Gary, Indiana, who is coordinating the anti?Bock marches next Wednesday sent a statement urging a massive turnout. He said the marches, set so far for Detroit, New Orleans, Los Angeles, Chicago, Cleveland, Washington, Houston, Birmingham, Oakland and Indianapolis, will include Black and white, women, young and old, ethnic and religious groups.

"The response has been strong from church communities across the nation and major unions as well," Hatcher said.

Santa Cruz Rainbow against Bork

Joining the National Education Association and numerous civil and abortion rights organizations, the Santa Cruz County Rainbow Coalition is urging the U.S. Senate not to confirm Robert Bork's nomination to the U.S. Supreme Court, because he "would make the court subservient to the rightwing conservatives" and because his views on civil liberties "are contrary to the interests of the working people of this nation."

#### REED IRVINE AND ACCURACY IN MEDIA HONORED BY WORLD MEDIA ASSOCIATION

Congratulations to Mr. Reed Irvine, founder and chairman of Accuracy in Media. He has been awarded the 1987 Award for Ethics in Journalism by the World Media Association.

In his letter informing Reed of the award, Larry R. Moffitt, Executive Director of the World Media Association, states:

"I can recall many times when your voice was the first, and often the only, one raised in protest of media arrogance and deception. Your annual presence at media stockholders' meetings and your success in organizing letter?writing campaigns to keep the press honest, have made you a special kind of pariah in the better Georgetown salons... I have always admired you and I hope this award will be just the beginning of the recognition you have earned many times over by your selfless tenacity and endurance for the cause of media responsibility."

Reed Irvine is an example and inspiration to all who want to play an active role in the struggle for freedom. He is the living answer to the perplexing and often?heard question, What can I do? He saw a need, and he accepted the personal responsibility for meeting that need. Observing the arrogance, irresponsibility, and left?wing bias, which are demonstrated constantly by much of the U. S. media, he did not wait for someone else to act. He applied his limited resources of time, energy, and money to challenge the moguls of the media and upheld the banner of truth. He has performed miracles.

Reed has been a steadfast, unflinching colleague in the battle against communist tyranny for many years. We salute him.

## MALICE OR MADNESS

Gus Hall, General Secretary of the U. S. Communist Party, is the official spokesman for the U.S. Communists. He delivered the main report to the 24th National Convention of the Communist Party, U.S.A. which was held in Chicago on August 13.

Excerpts from his report are published in the August 18 edition of the communist newspaper, the PEOPLE'S DAILY WORLD. They present a picture of the past actions and future intentions of the U. S . A. which is so false that the sanity of the authors must be doubted. The report states:

"It is true, the Soviet Union is a powerful force for peace. It has taken the initiative. It will continue to be in the forefront of the struggle to free the world from the nuclear nightmare.

"But it is a serious mistake to sit on the sidelines and watch. There should be no illusions. There is not now, nor was there ever any basic change in the outlook and aim of U.S. imperialism. Since World War II, U.S. policy has been to dominate as much of the world as possible??economically, militarily, ideologically, politically and financially. This is the perpetual dream of 'The American Century.'

"This was the underlying rationale for dropping the atom bombs on Hiroshima and Nagasaki. This was the reason for the construction of 500 overseas, mostly nuclear, missile bases around the world.

"Instead of reducing these numbers, the Reagan Administration is building more. The all?out drive to build weapons of first?strike nuclear superiority is the nuclearization of the U.S. policy of world domination." (Page 4?A)

If the objective of the United States were world domination, it could have been attained with relative ease when the United States was the sole possessor of the atomic bomb. The U. S. failure to do this at that time is more persuasive to rational people than the paranoid rantings of the communists.

#### AMNESTY INTERNATIONAL AND THE DEATH PENALTY (PART II

In the Crusade newsletter of August 1, I published my letter of response to an appeal from Amnesty International for assistance in their campaign for "abolition of the death penalty".

I have received a long, courteous reply from Patrick Minges, Amnesty International's campaigner against the death penalty. It was accompanied by numerous documents in support of the abolition of the death penalty.

I have replied as follows:

"Dear Mr. Minges,

"I thank you for your courteous and informative letter in which you replied to my letter giving the reasons why I cannot support your campaign. You present the reasons why Amnesty International has chosen to campaign for the abolition of the death penalty persuasively. I agree with many statements which you make, but I am still far from convinced that you have chosen the right course.

"One statement with which I wholeheartedly agree is: 'The. death penalty is an extremely complex issue which does not lend itself to easy solution.' However, when dealing with such a complex issue, it is easy to ignore important aspects. Unfortunately, you have ignored the central and vital issue which I raised.

"I charge, and continue to charge, that the assurance that the death penalty cannot be administered for any crime, provides certain murderers with a strong incentive to kill any victims who could testify against them. This incentive is particularly strong in the case of kidnappers, rapists, and child molesters.

"I gave, as an example, the experience of a beautiful Australian girl, Anita Colby, who was the victim of kidnapping and gang rape, and who was killed in cold blood so that she could not bear witness against her attackers. I pointed out that her rapist?murderers took into consideration that they would risk no increase in penalty for killing their victim if they were caught, while they diminished their chance of being captured, tried, and convicted by killing her. What rational person can deny that this gives kidnappers and rapists an incentive to kill?

"You do not discuss this issue in your reply. I would appreciate receiving any rebuttal you have to my contention that, in certain cases, the knowledge that the death penalty has been abolished provides a strong incentive for the killing of the innocent.

#### CASTRO LAMENTS INCREASING CORRUPTION IN CUBA

The situation in Cuba is far from satisfactory. Fidel Castro affirms this in a speech to the Central Organization of Cuban Trade Unions on January 14, 1987. He states:

"During the course of the last decade, growing social and economic inequalities have developed in Cuba. A social layer of administrators and functionaries has emerged, bureaucrats who are little concerned with the problems of 'the modest workers'... They have sought support within the better?off layers of the working class who became accustomed to, and some of them corrupted by, unearned bonuses and privileges, as well as a few private farmers and 'middlemen' who managed to chalk up windfall profits on the sale of scarce food items and other consumer goods." Castro is confronting the identical problem in Cuba that faced Stalin in the Soviet Union and Mao in China. They have all found that the members of the communist party take advantage of their privileged position to feather their own nests.

The communists may be winning their war to enslave mankind. They are losing, and will continue to lose, their war to create the "Perfect Man".

### GUNS WITHOUT AMMUNITION WON'T WIN THE WAR AGAINST AIDS

There is a lot of big talk about waging a war against AIDS. But to date it is a phony war. It reminds me of a sick joke that was prevalent in my youth.

The Russian Army was fighting the German Army on the Eastern front. According to this sick joke, the Russian Army was divided into three groups: The soldiers in the first group had guns but no ammunition; the soldiers in the second group had ammunition but no guns; the soldiers in the third group had guns and ammunition, but the ammunition did not fit the guns.

Legislation has been proposed to make it a crime for one individual to "knowingly" transmit the AIDS virus to another. Most of the proposed legislation will be as useless as a gun without ammunition. All a guilty individual needs to say to escape punishment is: "I did not know I had the virus."

The ammunition will come when testing for the AIDS virus is universal and compulsory. It will then be possible to act intelligently to assure that the virus is not transferred to new victims.

The objective of a genuine war on AIDS must be to prevent the infection of one more person. Universal compulsory testing will be a major victory in the war to assure this.

# INSPIRING TESTIMONY

Nijole Sadunaite, a native Lithuanian, a nurse, and a Christian believer was arrested in 1975 and charged with helping the publication and distribution of the "Chronicle of the Catholic Church in Lithuania", which was classified as "anti? Soviet agitation and propaganda". She was sentenced to three years of labor camp of strict regime and three years of exile.

In her final statement at the trial, Nijole said:

"Today I am experiencing the happiest day of my life. I am being convicted for the Chronicle of he Catholic Church in Lithuania which fights against physical and spiritual tyranny. This is the same as convicting me for the truth and for loving people! What can be more important in life than loving people, than their freedom and their dignity? The greatest love is the love for your neighbor, and the struggle for human rights is the most glorious song of love. Let it resound in everyone's heart, let it never stop resounding!

"I have drawn a lot which is to be envied, a glorious predestination??not only the struggle for human rights and for truth, but a sentence for my active participation as well. My sentence will become my victory. My only regret is that I have given so little to people. With a light heart I will enter into incarceration for the freedom of others and I am even prepared to die so that others may live. Today, as I approach the Eternal Truth??Jesus Christ??I recall His words: ' are they which do hunger and thirst after nLgh?teovuvie: for they shall be filled.' How can I not rejoice, when Almighty God has promised that light will vanquish darkness, and truth and righteousness will be victorious over delusions and lies!

"I ask the court to release those who are now in prisons, camps and psychiatric hospitals for truth and righteousness and for the struggle for human rights. By doing so you will show your goodwill and will help our life to become harmonious and full of love; let the beautiful thought that 'man is brother to his fellow man' be finally realized." (The Samizdat Bulletin, June?1987, page 1)

Nijole suffered continual harassment and persecution after her return from exile, and went underground in 1983. While underground, she has written her memoirs, which describe her prison life and the life of her fellow?prisoners.

#### **CHRISTMAS CARDS**

I hope you like the design and message of this year's Christmas card, which is depicted in the accompanying newsletter. I also hope that you decide to use these cards and thereby convey loving greetings to family, friends, colleagues, customers and employees, while simultaneously helping preserve the opportunity of our children and grandchildren to enjoy the festivities associated with the spirit of Christmas.

No Debts

In the special letter to supporters, which accompanied the August 15 newsletter, I stated that the Crusade had spent \$276,265 more than it received during the months of April, May, and June. This true announcement gave the wrong impression to some. They thought we were engaging in deficit financing and accumulating debt.

This is not so. Our ability to spend more than we received during those months is due to the relatively large donations received in December. In December, 1986, we received \$720,000, while expenditure for the month was \$241,000. This left a reserve of \$479,000. I was concerned that this reserve would soon be exhausted if we continued to deplete it at the rate which prevailed in April, May and June, and we would be faced with going into debt or reducing our program. The Crusade will not accumulate debts.

Balancing U S and Worldwide Anti?Communism Activity

The responses to my appeal for advice on the best way to utilize our resources continue to arrive. I presented three options: 1) Increase activities within the U.S.A.: 2) Increase activities in Central America, the Philippines, and overseas countries; and 3) Maintain the balance between work in the U.S.A. and overseas.

The great majority of responses received to date favor the third option, and we are endeavoring to follow this course.

The Blessings of Life in the US. A

Many of the letters we receive bring tears to my eyes and a song to my heart. I share the concluding passage of one I have just opened:

"Thank you, Dr. Schwarz, for the great service you are doing in alerting the free world. I, too, know what Communism is. My mother, grandmother and I escaped during WW II from Latvia. My father did not succeed in escaping with us. He is still there. I have been trying since 1970 to obtain a visitor's visa for him... Our story is one of many. It is dark and tragic, yet touched by the beauty of God's love and care.. touched by the beauty of His light..."

How grateful to God we should be for the privilege of living in the U.S.A. Most of us have never known the pangs of hunger nor the lash of the tyrant. May God grant that the communist campaign to change this may be defeated.

Will you express your gratitude to God by making a sacrificial gift to maintain freedom from communist tyranny here, and to expand liberty everywhere?
